» MONTHLY PROGRAM RATES

Rates are based on 180 days of school to calculate a **FLAT MONTHLY FEE** equating to nine equal payments from September to May. A prorated fee will be applied if school is in session more than 180 days. Credits will not be given for non-attendance or for days when the school district chooses to close, such as inclement weather.

A \$25 Registration Fee will be applied to your account at time of registration. All fees must be paid monthly. Families will receive a 10 percent discount for each additional child registered.

I understand that by signing this form, I am responsible for all fees for the YMCA School Age Program. I understand that the registration fee is non-transferable and non-refundable. I understand School Age fees must be paid monthly and in advance of the service. I understand that failure to pay fees may result in a late fee of \$10 per week. I understand fees are established based on schedule, not attendance. This is a flat monthly fee with no credit for time off, holidays or vacations. I am required to give a two-week notice for a permanent schedule change and/or withdrawal which affects the number of days my child will attend the YMCA School Age Program. Adjustments to the monthly rate will be made two weeks after initial date of notice to customer service.
