## OPEN POSITION ANNOUNCEMENT

- Position:** Aquatic Lead Coordinator (FT – Hourly)
- Location:** Rite Hite, Northside, & Northwest YMCA (All Facilities included)
- Reports to:** Product Director of Aquatics
- Wage Range:** \$10.50 – \$13.50 per hour

### **Major Responsibilities:**

- Manager on Duty for the Northwest YMCA facility (Seasonally). This includes: On-deck supervision of staff during scheduled hours, serving as waterfront supervisor for various licensed camp groups, working with the Aquatics Manager and Aquatics Director to develop Northwest YMCA staff schedule.
- May require up to 30 hours of lifeguarding or teaching each week as needed during the Fall, Winter, and Spring at The Rite Hite and Northside Facilities.
- Lead staff safety trainings & lifeguard trainings as scheduled by the Product Director of Aquatics. Prepare paperwork for submission of Safety Certifications.
- Accountable to the Product Director of Aquatics for execution of Policies and Procedures of the Association.
- Ensures that daily care of the members is a key priority through supervision and collaboration with center staff in the absence of the Aquatic Manager or Aquatic Director
- Strictly adhere and be accountable for the execution of all Association and Aquatics Policies and procedures related to safety, conduct, rules and other regulations- serve as a Subject Matter Expert other centers.
- Support the Aquatic Director of the Center, Aquatic Staff, and programs by providing direction and support.
- Support quality program delivery through staff excellence in an effort to achieve programmatic outcomes.
- Represent and articulate the Associations Aquatics Mission and program to individuals, businesses and communities as designated by Product Director of Aquatics. Other Duties as assigned.
- Other Duties as assigned.

### **Qualifications:**

- Must have 2 years of college or a combination of education and experience
- Must have at least 1 year of aquatic supervisory experience with staff/volunteers and programs, and minimum of 2-3 years of successful Aquatic work experience that includes instructional, lifeguarding or specialty aquatic activities is required
- Current certifications in CPR/AED for the Professional Rescuer, Administering Emergency Oxygen, and Standard First Aid, ARC Lifeguarding & Lifeguard Instructor.
- Proven ability to display initiative, good judgment and ability to make decisions with minimal input.
- Ability to coordinate and prioritize multiple tasks in a fast paced environment with interruptions.
- Ability to work with different people in different situations & settings.
- Leadership skills, self-driven, detail oriented, and capable of dealing with department issues effectively
- Must demonstrate excellent computer (Windows Office and Daxko) skills, as well as, written and verbal communication skills
- Must have the ability to travel to centers within the course of the workday and evening.
