## SOCIAL EMOTIONAL LEARNING (SEL)

Social Emotional Learning (SEL) utilizing Sanford Harmony Curriculum. SEL is the process through which children and adults understand and manage emotions, set and achieve positive goals, feel and show empathy for others, establish and maintain positive relationships, and make responsible decisions. In our programs we use SEL to help children learn, understand, control, and manage their own emotions and strengthen their social skills.

MONTHLY PROGRAM RATES

Fees are based on a 180 day school calendar with a **FLAT MONTHLY PAYMENT**, August-June. Months which contain Winter and Spring Break will be prorated one week. June will also be prorated.

I understand School Age Program fees must be paid monthly and in advance of the service. I understand that failure to pay fees may result in a late fee of \$10 per week. I understand fees are established based on schedule, not attendance. **This is a flat monthly fee with no credit for time off, holidays, vacations, absences due to illness or behavior.** I am required to give a four-week notice for a permanent schedule change and/or withdrawal which affects the number of days my child will attend the YMCA School Age Program. Adjustments to the monthly rate will be made four weeks after initial date of notice to customer service. I understand that any schedule change must be made in writing to the email or mailing address listed in this brochure.
